8. Winners will be announced at the conclusion of the pageant.

MISS SPRING CITY CONTRACT OFFICIAL RULES AND REGULATIONS

1. Individuals competing in the Miss Spring City Scholarship pageant will be eligible to compete in the Miss Sanpete Pageant.
2. The time, manner and method of judging shall be solely within the discretion of the Miss Spring City judges. The decision of the judges is final. No scores will be shared, discussed, and viewed either in written or verbal format with the contestants or their respective parties. The judges sign all score sheets.
3. A contestant must be single and never have been married, had her marriage annulled, nor may she have cohabitated with a male in lieu of a marriage contract and must not be pregnant.
4. A contestant must not use, have used, or have a history of use with tobacco, alcohol, or illegal substances.
5. A contestant will be of good moral character and must not have been involved nor involve herself with, at any time, immoral, illegal, or illicit behavior.
6. A contestant must be at least fifteen (15) years old and no older than twenty (20) at the time and duration of pageant.
7. A contestant must be a resident of Spring City with a zip code of 84662.
8. The Miss Spring City Royalty will assist in making the parade float. They also shall participate in the required parades throughout Sanpete County.
9. The winner of the Miss Spring City Scholarship Pageant will be required to complete her service project within the time of her reign. The proposed service project will be created by Miss Spring City and must be approved by the Spring City Scholarship committee and judges.
10. The winner of the Miss Spring City Scholarship pageant will receive a \$1,000 award that will be issued directly to the higher educational college, university, or vocational trade school of her choice. There will be no cash or check exchanged directly with the winner or her respective parent(s)/guardian. The award will only be issued to the higher education institution she has been accepted to or is currently attending. Any violation of this contract or found violation at any time of reign, will result in the forfeiture of said scholarship.
11. The scholarship will be awarded upon completion of the service project and acceptance to the winner's choice of higher education and cannot be awarded prior to such.
12. If at any time during the competition for which the winner will be selected, it is determined that the Miss Spring City recipient is no longer eligible for the title, it becomes the sole discretion of the Spring City Scholarship committee to award the title to the next qualifying attendant. If the current Miss Spring City Scholarship winner is determined to no longer be eligible for any reason, her title and scholarship will be forfeited. The next qualified attendant, determined by the Spring City Scholarship committee, will be subjected to the provisions of this contract.
13. This contract must be understood and signed (and undersigned by a parent/guardian of anyone under the age of eighteen (18). It is considered legal and binding. It must be submitted as a part of the entire application packet and written requirements. You will not be considered a contestant without this signed contract. You agree to be bound by this agreement and its said attachments.
14. Miss Spring City Royalty will assist with city celebrations and events throughout the year of their reign, as requested.
