

## 2026 ICUA Youth Rally Program



### **What is the Rally Purpose?**

The Rally is a leadership camp and scholarship program for youth from Idaho and surrounding states to learn about government, consumer-owned utilities, and the energy industry. Youth work in teams to solve challenges, puzzles and participate in obstacle courses. There is a trip to the Idaho Capitol and the nearby waterpark.

### **How to get the Scholarships?**

1. Youth that are selected to receive an ICUA Youth Rally sponsorship will receive a \$500 scholarship for being the winning essay entry for UAMPS.
2. Youth are also evaluated throughout the camp on class engagement, participation, teamwork, leadership and overcoming obstacles to earn additional scholarships at the ICUA Youth Rally.

### **UAMPS to Sponsor Youth to Attend and Award a Scholarship**

UAMPS will award four (4) youth an invitation to attend an all-paid round trip between Salt Lake City and Nampa, Idaho to attend the Youth Rally from **July 6-10, 2026** at Northwest Nazarene University in Nampa (the “UAMPS Sponsorship”). The UAMPS Sponsorship is awarded to essay contest winners who desire to learn more about the electric utility industry. **Each of the four (4) winners will also receive a \$500 scholarship from UAMPS for their essay submissions.** Youth will have the opportunity to win additional scholarship money at the Youth Rally.

### **Guidelines for submission**

Since decisions by judges and disqualifications according to the guidelines are final, entrants should read and follow these guidelines closely.

Essay entries are to interpret one or more aspects of the theme, **“Consumer-Owned Utilities: Why Having a Diverse Power Portfolio Is Important To Utilities.”** This applies to municipal electric utilities, rural electric cooperatives, public utility districts and water conservancy districts. Judges will look particularly for originality and the relevance of the theme to the writer and their consumer-owned utility.

**Current high school sophomores and juniors are eligible.** Those eligible must have a legal guardian who is a customer of a UAMPS member consumer-owned utility or attend high school in a member city. Essays are to be original and from 500 to 750 words, typed and double-spaced.

All essays are to include a cover page, with the writer’s name, the year of high school they are currently attending as of Spring of 2026 (sophomore/junior), mailing address and headshot type photo of themselves.

Essay entries shall be submitted to the governing body of the consumer-owned utility (UAMPS member) by **April 3, 2026.** (The governing body may appoint a separate individual or group to judge entries.). The Member will send its winning essay to UAMPS for entry in the final selection of the UAMPS Sponsorships. The deadline for submitting essay entries to UAMPS is **April 10, 2026.** The executive committee of UAMPS will select the final four (4) essay winners, with an announcement via email by **April 27, 2026.**
